



Firearms Safety Course Student Agreement and Liability Release

I hereby release the National Rifle Association (NRA) and the Three-Peaks Shooting Club, their officers, directors, instructors, agents and employees, and those other organizations affiliated with this course from any liability, loss, damage, costs, claims and/or causes of action, including but not listed to all bodily and personal injuries and death and property damage, arising out of my participation in firearms training courses taught by Three-Peaks Shooting Club, it being specifically understood that said course includes the operation and use by the undersigned and others of firearms and ammunition. This release is given on behalf of my heirs, successors, executors, administrators, assigns and myself.

I agree to abide by all safety rules required by the NRA and the Three-Peaks Shooting Club.

I understand that the safe and proper use of firearms requires a positive attitude based on maturity, responsibility, ethics and respect.

I understand that there are inherent and other risks involved in the use of guns and ammunition in shooting, and I freely and voluntarily assume and accept those risks.

I understand that my instruction may be terminated at any time, and my fee forfeited, if my cooperation is deemed to be unsatisfactory by the instructors or if my behavior or actions are deemed to be a risk to others or myself or if, in the opinion of the instructors, I fail to demonstrate the proper attitude and knowledge necessary for the safe and proper use of firearms.

I understand that this course presents general information regarding firearm safety, self-defense and the law and that it is not intended to be comprehensive in any way nor is it intended as legal advice. I understand that the laws governing firearm ownership, possession and self-defense are subject to frequent changes through legislation and court interpretation and that nothing in this course shall be taken as a definitive guide to the laws in my jurisdiction. For any legal questions, interpretations or advice, I will consult with a knowledgeable attorney.

I certify that I am at least 18 years of age, have never been convicted of a felony, have never been institutionalized for any mental disorder, or am otherwise restricted from handling or possessing firearms.

If the student is not at least age 18, the undersigned parent or guardian also agrees to this Firearms Safety Course Student Statement and Liability Release Agreement in which case this also constitutes permission for the student to handle any firearm pertaining to this training under the supervision of the Three-Peaks Shooting Club.

The applicable laws of the State of Utah govern this agreement. If any part of this agreement is determined to be unenforceable, all other parts shall be given full force and effect.
